The company also focuses on HUMXin technology platform, a program to develop chimeric and fully humanized fusion proteins based upon the Bcl-2 family of proteins. It has a collaborative research and clinical development agreement with BrainLAB AG for use of the BrainLAB proprietary drug delivery software iPlan Flow to plan treatments and catheter placement for delivery and distribution of PRX321. The company was founded in 2002 and is headquartered in Vancouver, Canada.
