Market Area

The company conducts its business from eight full-service banking offices and one loan origination center, which are located in Windham County and New London County, Connecticut.

Lending Activities

The company's principal lending activity has been the origination of first mortgage loans for the purchase or refinancing of one- to four-family residential real estate. It sells long-term fixed rate loans in the secondary market. It offers one- to four-family residential

real estate mortgage loans (including home equity loans and lines of credit), commercial real estate loans (including multi-family real estate loans), commercial loans, construction mortgage loans (primarily secured by single-family properties), and consumer loans.

Residential Mortgage Loans: The company's primary lending activity consists of the origination of one- to four-family residential mortgage loans that are primarily secured by properties located in Windham County and New London County.

Commercial Real Estate Loans: The company originates commercial real estate loans, including multi-family real estate loans that are secured by five unit or more apartment buildings, construction loans, and loans on properties used for business purposes, such as small office buildings, industrial facilities or retail facilities primarily located in its primary market area. It also offers real estate development loans to licensed contractors and builders for the construction and development of commercial real estate projects and one- to four-family residential properties.

Residential Construction Loans: The company originates construction loans to individuals for the construction and acquisition of personal residences.

Commercial Loans: The company offers commercial business loans primarily in its market area to a variety of professionals, sole proprietorships, and small businesses. Commercial lending products include term loans and revolving lines of credit.

Consumer and Other Loans: The company offers a limited range of consumer loans, principally to Putnam Bank customers residing in its primary market area with acceptable credit ratings. Its consumer loans consist of loans on new and used automobiles, loans secured by deposit accounts and unsecured personal loans.

Investment Portfolio

The company's investment portfolio includes U.S. Government and agency securities, corporate bonds and other securities, mortgage-backed securities, and equity securities.

Deposits

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
