#### Segments

The company has two segments: the Completion Services Segment and the Drilling Services Segment, which carry on business through various operating divisions.

### **Completion Services Segment**

The Completion Services Segment carries on business in both Canada and the United States through various operating divisions.



Production Testing Divisions(Canadian and United States)

The company's both the Canadian and United States Production Testing Divisions offer production testing services using enclosed production testing tanks of different sizes depending on pressure ratings and volume capacity. Both the Canadian and United States Production Testing Divisions also process raw production testing data, which verifies and standardizes the presentation of the data for final distribution to customers.

Services: Services offered by the Production Testing Divisions include: Production Testing, Fracturing Fluid Flow Back Services, Swabbing, Absolute Open Flow, Underbalanced Drilling Services, and PAS filing services.

Customers: The Canadian Production Testing Division had approximately 140 customers as of September 30, 2005 and the United States Production Testing Division had a total of five customers as of September 30, 2005.

Logging and Perforating Divisions (Canadian and United States)

The Canadian Logging and Perforating Division provides cased-hole electric wireline services. Using electric wireline units, the Canadian Logging and Perforating Division offers cased-hole logging and perforating services in major producing areas in the WCSB, and the United States Logging and Perforating Division has received delivery of two cased-hole electric wireline trucks which would begin operating in the Rocky Mountain region in the year 2006.

Services: Services offered by the Canadian Logging and Perforating Division include, and in the case of the United States Logging and Perforating Division would include: Perforating Services; Specialty Logging including Bond logging, Casing inspection, and Casing vent leak logging; Production Logging; and Downhole Video Camera Services.

Customers: The Canadian Logging and Perforating Division had approximately 182 customers as of September 30, 2005.

#### Multiline Services Division

The company, through the Multiline Services Division, offers slickline and combination slickline/electric line services in major producing areas in the WCSB. This division operates from five locations in Alberta and British Columbia. Slickline services are used



on cased wells using non-electric wireline of various sizes during the completion, testing and maintenance phases of operating oil and natural gas wells. Slickline services are performed in various downhole environments, including at high pressure, with sour natural gas, and at significant well depths. The Multiline Services Division focuses on two service areas, namely bottom hole pressure (BHP) services and completion services for high pressure critical sour natural gas wells. BHP services involve running recorders into a well to monitor downhole conditions.

Services: Services offered by the Multiline Services Division include: Pressure Recorder Services, Completion Services, Electric Line Services, Fishing Services, Downhole Camera Services, and Pressure Transient Analysis Reports.

Customers: The Multiline Services Division had approximately 155 customers as of September 30, 2005.

# **ANALYSIS FEATURES**

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

#### **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Physical

Technological

Organizational

Intangible resources Human

Innovation and Creativity



Reputation

Organizational capabilities
