#### Properties

The company owns interests in various properties, including Holdsworth Property; McFauld's Lake – MacDonald JV Property (McNugget); Cluff Lake Property; Charlebois Lake Property; and Grand Calumet Property.

**Holdsworth Property:** The company owns 100% interest in 19 mining claims in the District of Algoma, Sault Ste. Marie Mining Division of Ontario covers approximately 760 acres. Of these claims, 16 are located in the southern part of Corbiere Township, Ontario, and the other three extend into the northern part of Esquega Township, Ontario.

**McFauld's Lake – MacDonald JV Property (McNugget):** The property consists of 36.75% interest in the McFauld's Lake Area of the Thunder Bay Mining Division, near the western edge of the James Bay Lowlands, Ontario. The property consists of approximately 3,680 acres.

**Cluff Lake Property:** The company owns 100% interest in approximately 40,000 acres of ground in 5 blocks adjacent to and on strike with the Cluff Lake Uranium Mine, Saskatchewan.

**Charlebois Lake Property:** The company owns an option to acquire 100% interest in nine mining claims in the Charlebois Lake Area of the Northern Mining District, Saskatchewan which cover approximately 10,512 acres.

**Grand Calumet Property:** The company has an option agreement with Globex Mining Enterprises Inc. (Globex), to earn a 70% interest in Globex's 100% owned Grand Calumet uranium-fluorite property. The property is located in Grand Calumet Township, northwest of Hull, Quebec.

The company has an option to acquire a 100% interest in 20 mining claims that are located in Grand Calumet Township, Quebec. It has another option to acquire 100% interest in 6 registered mining claims and 13 pending mining claims located in Grand Calumet Township, Quebec.

**Cortez-Gladwin Property:** The company owns an option to acquire 19 mining claims in Cortez Township, Ontario and Gladwin Township, Ontario in the Elliot Lake area of northern Ontario. The 19 mining claim units cover 293 claims that consist of approximately 11,720 acres. The company staked an additional 160 claim units with approximately 6,400 acres.

The company, through its wholly-owned U.S. subsidiary, Hawk Uranium USA, Inc. (Hawk USA), holds an investment in Wits Basin Precious Minerals Inc. (Wits Basin), which has investments in various mining properties worldwide.

Hawk Uranium Inc. was founded in 2003. The company was formerly known as Hawk Precious Minerals Inc. and changed its name to Hawk Uranium Inc. in 2007.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
