Principal Products

The company has three principal products and product lines: the 'Lamella Inclined Tube Settler Waste Water Treatment System,' the 'Circulating, Fluidized Bed, Flue Gas Desulphurization System,' and the 'High Temperature Anti-Oxidation System for Hot Rolled Steel.'



Lamella Inclined Tube Settler Waste Water Treatment System

The company's core product, the Lamella Inclined Tube Settler Waste Water Treatment System (the 'Waste Water System'), is a wastewater treatment system that incorporates its proprietary and patented 'Lamella Inclined Tube Settler' technology. It includes industrial water treatment equipment, sets of effluent-condensing equipment, solid and liquid abstraction dewatering equipment and coal gas dust removal and cleaning equipment.

The company's combination of proprietary system design and patented technology allows wastewater to flow through the system in layers while at the same time settling particulate matter without disturbing the water flow.

Circulating, Fluidized Bed, Flue Gas Desulphurization System

The Circulating, Fluidized Bed, Flue Gas Desulphurization System (the 'Desulphurization System') is a system that removes particulate sulphur from flue gas emissions generated by the sintering process in the production of iron and steel (a process in which sulphur and other impurities are removed from iron ore by heating, without melting, pulverized iron ore) with the resulting discharge meeting all relevant PRC air pollution standards. Without treatment, flue gasses that result from sintering contain high content of sulphur dioxide which reacts with atmospheric water and oxygen to produce sulphuric acid that precipitates as 'acid rain.'

High Temperature Anti-Oxidation System for Hot Rolled Steel

The company's High Temperature Anti-Oxidation System for Hot Rolled Steel (the 'Anti-Oxidation System') is a set of products and a mechanized system that reduces oxidation-related output losses in the production of continuous cast, hot rolled steel. In addition, oxidation in high-temperature steel production results in the waste of water and energy and generates pollution.

The company's Anti-Oxidation System is specifically designed to work with hot rolled steel product in high temperature environment. Each unit of its Anti-Oxidation System services one steel line.

Contract Machining Services

The specialized heavy machinery and equipment that the company uses to produce its,



Lamella Wastewater System, Desulphurization System, and Anti-Oxidation System also provides the company with a capacity to undertake the machining of high-precision and advanced structures. The company maintains strategic cooperation relationships with Dalian Heavy Industry (Zhonggong) and China First Heavy Industries with which the company contracts to provide production time on its heavier machine tools, during 'down time' on its own production.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis
