During 2009, the company conducted 195 unreserved industrial auctions at locations in North and Central America, Europe, the Middle East Australia, and India. The company also held 132 unreserved agricultural auctions in Canada.

The company's proprietary customer database contains approximately 620,000 customer names from approximately 200 countries. The company typically sends approximately 45,000 full-color auction brochures for each auction to strategically selected customers from its database. The company also conducts targeted regional and industry-specific advertising and marketing campaigns. In addition, the company posts information about the majority of the consigned equipment at upcoming auctions on its Website so that potential bidders can review equipment descriptions and view photographs of many of the items to be sold.

The company solicits equipment consignments ranging from single pieces of equipment consigned by local owner-operators to large equipment fleets offered by multi-national consortiums upon the completion of construction projects. For larger consignments, the company's service typically begins with an equipment appraisal that gives the prospective consignor a credible estimate of the value of the appraised equipment.
