Properties

Voltaire Project, Ontario

The company holds 100% interest in a 37,320 acre mineral property, including 933 units known as the Voltaire Uranium Property in the central Sibley Basin. It also staked an additional 14 claims to the west of the original Voltaire Uranium Property. The company acquired a further 6,800 acres, known as the Gull Bay Property, to the east of the original Voltaire Uranium Property. It staked approximately 10,000 acres on the east side of the Gull Bay Property. The total property area is approximately 60,000 acres.

In 2008, the company staked 13 additional claims, including 205 claim units of 16 hectares each. These claims are located immediately south of the mineralized zone intersected in drill holes on the property. This brings the Voltaire Lake property to a total area of 33,100 hectares or 81,760 acres.

South Maverick Project, Saskatchewan

The company entered into an option agreement to acquire a 100% interest in the south Maverick Uranium Property, consisting of approximately 4,181 hectares in the Athabasca basin.

St Urbain Project, Quebec

The company acquired a 100% interest in the Saint Urbain Titanium and Iron Project in Quebec. The property consists of 33 claims covering approximately 1,917 hectares. In 2008, the company staked 217 additional claims around 33 initial claims bringing the total size of the property to 250 claims covering 14,522.7 hectares.

Hornby Basin Property

The company entered into a purchase agreement to acquire the Hornby Basin Property, a 90,000-acre property on the North West Territories/Nunavut border. It has an option to acquire additional property in the Hornby area of the North West Territories. The property consists of 19 claim blocks totaling approximately 35,000 acres.

TILAMA copper project

The company announced the acquisition of a right of first refusal and a 120 day standstill agreement respecting the purchase of a 100% interest in the TILAMA copper project in Northern Chile.

Other Properties

The company has an option to acquire the Gin Claims, a 6,620 acre property in Northern BC contiguous to the Red Chris property in the Stikine Arch.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
