The Haile Gold Mine is located in Lancaster County, South Carolina and is the company's primary property. The 2009 exploration program consists of 85,000 meters (270,000 feet) of reverse circulation drilling in approximately 500 holes averaging 700 ft (218 meters) in depth.

#### McDowell Tract

In 2008, the Haile entered into an agreement with a private party to purchase land adjoining the Haile Gold Mine in Lancaster County, South Carolina.

#### Pinos Gold District, Mexico

In 2006, the company entered into two agreements with Minera Apolo SA for the Pinos Gold District in Mexico.

Catanava: The company has a 50/50 Joint Venture with Minera Apolo. Upon completion of an approximately 180 day drilling program, it has the option to provide the financing for an approximately 350 tonnes per day plant.

Old Pinos District – 100% exploration/exploitation license: The company has been granted a 100% right to explore and exploit this project area.

Pine Grove, Nevada

In 2005, the company and Toquima Minerals US Inc. (Toquima) agreed to enter into an option agreement whereby it has an option to earn a 60% interest in the Pine Grove Project. The Pine Grove Project is located in Lyon County, Nevada.

### Significant Events

On January 19, 2010, Romarco Minerals Inc. announced the acquisition of additional property along the mineralized trend at the Haile Gold Mine in South Carolina. The company controls 7 kilometers of strike length along the Haile mineralization corridor (not including Buzzard). The company has also increased its land ownership in the Buzzard area by an additional 396 acres. The total land package owned 100% by Romarco is 3,217 acres. All land is private land and there are no royalties on any of the land parcels.

### History

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
