These properties are located in the northern part of Neuquen Province in central-western Argentina. The claims were acquired by staking, and the company holds a 100% interest. The Varvarco Gold and Porphyry Project cover 17,390 hectares.

San Isidro Property, Mexico

The San Isidro property is located in Michoacan State, Mexico. Certain of the claims (San Juan III and La Laguna) were acquired by staking, and the company holds a 100% interest.

Inguaran Property, Mexico

The Inguaran property is located in Michoacan State, Mexico. The claims were acquired



by staking or outright purchase (Manga concession) and the company holds a 100% interest in them. The company optioned additional claims to add to the Inguaran Property. The terms of these option agreements allowed the company to acquire a 100% interest. Rome's Inguaran Valley Porphyry Copper-Tungsten Project in the Inguaran Valley totals approximately 6,245 hectares.

Sonora Project, Mexico

The Sonora properties consist of the Don Luis Tungsten gold property, the La Colorada gold property and the Los Muertos gold-silver property. The company's Los Muertos Silver-Gold Property is approximately 80 kilometers southeast of Hermosillo in central Sonora, Mexico. The concessions covering this property form two blocks, including Los Muertos North and Los Muertos 3, and Los Muertos South. Los Muertos North and Los Muertos South cover approximately 2,103.0 hectares and 558.4 hectares, respectively; they total approximately 2,661.4 hectares. These 4 concessions are in the name of Roma Recursos de Mexico S.A. de C.V., a wholly owned Mexican subsidiary of Rome Resources Ltd.

The company's Don Luis Tungsten-Gold-Molybdenum-Copper Greisen-Porphyry Property is in central Sonora, Mexico, approximately 45 kilometers north of Hermosillo, the capital of Sonora. Rome holds a total of 30,347 hectares by option of 450 hectares from Sr. Luis Ayala Barragan and Sra. Agripina Ayala Guerrero, applications for the Grecia (3,100 hectares), Alberto (9,867 hectares) and Ontario (16,930 hectares) by Roma Recursos de S.A. de C.V., a wholly owned subsidiary of Rome.

La Verdosa Property, Mexico

The La Verdosa copper property is located in Michoacan State, Mexico.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
