Food and Beverage Preparation

The company's food preparation products consist of food processors and food preparation appliances, and mixers. Its offers filter and espresso coffee makers, and electric kettles for beverage preparation. It also offers mini-mincers and hand-held mixers; kettles; juice extractors and coffee mills.

Electric cooking

The company's electrical cooking appliances comprise toasters, electric fryers, steam cookers, barbecues, waffle makers, tabletop ovens and informal meal appliances, electric cooking stones, and fondue sets. It offers the Fridelys and Urbalys electric fryers equipped with a keep-warm drawer, the Snack Oleo Clean mini fryer with its oil-filter and the super-compact Neve raclette grill with a single cooking surface, and the Delisnack toaster-oven with its reheating function. The company also offers steam cooking with the Sesame, a low-pressure cooker. Its lid adjusts to three positions for fast cooking, 5-second depressurization, or lid opening, making it possible to interrupt cooking at any time to add ingredients.

The All-Clad portfolio comprises sets of saucepans, saute pans, frying pans, bakeware and other kitchen utensils and accessories. The company uses the All-Clad brand to market six roll-bonded collections, including one with a nonstick coating, and two ranges of utensils under the Emeril label, which are finished respectively in stainless steel and anodized aluminium. It also offers a range of baking moulds and oven dishes, as well as a small number of electric cooking products.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

How to overcome the weaknesses that can make the threats a reality?

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
