The Company's two current protein-based pharmaceutical product candidates are:

Insulin: The Company is developing insulin to serve the diabetes market and to facilitate the commercialization of alternative insulin delivery technologies. If abbreviated clinical trial protocols apply, the company's project this product candidate, which is in the research phase, could reach the market as early as 2008 or 2009.

Apolipoprotein (AI-class): The Company is developing apolipoprotein A-I and apolipoprotein A-IMilano (collectively, Apo AI) to be used in formulations that will serve as cardiovascular therapeutics to reduce and stabilize vascular atherosclerotic plaques which are associated with acute coronary syndrome (ACS), including heart attack and unstable angina, and stroke indications. These product candidates are in the research



phase. The company is also using its technology platform to develop nonpharmaceutical products.

Technology

The Company's oilbody-oleosin technology is one among transgenic technologies that addresses protein recovery and purification simultaneously with bulk protein production.

The Company has developed a number of products and product development systems based on these capabilities, including production and purification of recombinant proteins (its Stratosome[™] Biologics System and its Affinity Capture System); antibody purification reagents (its StratoCapture[™] Purification System); purified non-recombinant oilbody products (its DermaSphere[™] Ingredient System and its StratoDerm[™] Skin Care System); and seeds containing recombinant oilbodies (animal health products).

In addition, the company's ability to develop transgenic oilseed products has enabled its to initiate modified seed oil product development programs (GLA and DHA rich safflower oils).

SemBioSys currently operates a 1,800 square foot pilot plant, capable of processing approximately 100 kilograms of seed per hour to produce approximately 40 kilograms of oilbodies.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
