## Sensors Products

The company supplies automotive, commercial, and industrial sensors, including pressure sensors, pressure switches, and position and force sensors. Its sensors are used in various applications, including automotive air-conditioning, braking, transmission and air bag applications, as well as heating, ventilation, and air-conditioning (HVAC), and heavy vehicle off-road (HVOR) applications. The company's sensors are customized devices that translate a physical phenomenon, such as force or position into electronic signals that microprocessors or computer-based control systems



can act upon.

#### Controls Products

The company provides bimetal electromechanical controls, thermal and magnetic-hydraulic circuit breakers, power inverters, and interconnection products. It manufactures and markets a portfolio of application-specific products, including motor and compressor protectors, circuit breakers, semiconductor burn-in test sockets (BITS), electrical HVAC controls, power inverters, and precision switches and thermostats. The company's controls are sold into industrial, aerospace, military, commercial, and residential end-markets. Its controls are customized devices embedded within systems to protect them from excessive heat or current.

The company's product line encompasses four categories of controls, including bimetal electromechanical controls, thermal and magnetic-hydraulic circuit breakers, power inverters, and interconnection each of which serves a diversified base of customers, end-markets, applications, and geographies. The company's magnetic-hydraulic circuit breakers serve a spectrum of OEMs and other multi-national companies in the telecommunication, industrial, recreational vehicle, HVAC, refrigeration, marine, medical, information processing, electronic power supply, power generation, over-the-road trucking, construction, agricultural, and alternative energy markets. The company provides thermal circuit breakers to the commercial and military aircraft market.

The company's power inverters products allow an electronic circuit to convert DC to AC. Power inverters are used mainly in applications where DC power, such as that stored in a battery, must be converted for use in an electrical device that runs on AC power. Its interconnection products consist of semiconductor BITS used by semiconductor manufacturers to verify packaged semiconductor reliability.

#### Customers

The company's customer base in the sensors business includes a range of equipment manufacturers (OEMs) and Tier 1 suppliers in the automotive, industrial, and commercial end-markets, including BMW; Chrysler Group; Continental; Ford Motor Company; General Motors; Honda Motor Company; Peugeot Citroen; Renault/Nissan; TRW Automotive; and Volkswagen.

The company's customers in the controls business include a range of industrial and commercial OEMs and Tier 1 manufacturers across multiple end-markets, primarily



OEMs in the climate control, appliance, semiconductor, datacomm, telecommunications, and aerospace industries, as well as Tier 1 motor and compressor suppliers. Its major customers include A.O. Smith; Bosch; Emerson Electric; Flame Enterprises; Giatek Corporation; LG Group; Peerless Electronics; Regal Beloit; Samsung; and Whirlpool.

# Competition

The company's principal competitors in the market for automotive sensors are Robert Bosch GmbH and Denso Corporation which are in-house, or captive, providers; and Nagano Keiki Co., Ltd. and Schneider Electric, which are independent. The company's principal competitors in the market for commercial and industrial sensors include Saginomiya Seisakusho, Inc. and Schneider Electric.

The company's primary competitors in the basic alternating current motor protection market include Asian manufacturers, such as Jiangsu Chengsheng Electric Appliance Company Ltd.; ChwenDer Thermostat & Company Ltd.; Wanbao Refrigeration Group Guangzhou Appliances Company Ltd.; Hangzhou Star Shuaier Electric Appliance Co., Ltd.; Ubukata Industries Co., Ltd.; and Foshan TongBao Corporation Limited.

The company's competitors in the thermal circuit breaker, thermostat and switches markets include Cutler Hammer, a division of Eaton Corporation; and Crouzet, a division of Schneider Electric, in aircraft circuit breakers; Honeywell International Inc. in aircraft switches and thermostats; and Cooper Bussman, a division of Cooper Electric, in heavy and off-road thermal circuit breakers. The company's competitors in magnetic-hydraulic circuit breaker markets include Carling Technologies, Circuit Breaker Industries, and the Heinemann brand of Eaton Corporation.

# **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

# **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

# IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
