#### **Properties**

The company owns, or has the option to earn a majority ownership in, nine properties in British Columbia and one in the Yukon Territory.

**Capoose Property:** The company has an option to acquire 100% interest in the Capoose Property, located approximately 185 kilometers west-southwest of Prince George, British Columbia. The property covers known mineralized zones and exploration targets indicative of a disseminated silver-gold system. The property totals 812 hectares.

**Silver Trend Property:** The company holds a 100% in the Silver Trend Property located in British Columbia. The property consists of eight claims covering 3,600 hectares acquired by the company by staking.

**JAG Property:** The company has entered into an agreement with Piotr Lutynski pursuant to which it purchased outright one claim and entered into an option to acquire a 100% interest in six additional claims with gold and silver soil geochemical anomalies. Collectively, the seven claims are referred to as the 'JAG' property, which is contiguous to and located directly northeast of the Capoose-Silver Trend property.

**Slate Falls Gold Property:** The company has an agreement to acquire 100% in the Slate Falls Gold Property, located in the Sioux Lookout District of northwestern Ontario. The property comprises three claims totaling 48 units (768 ha) and is located 120 kilometers north of the community of Sioux Lookout.

**3Ts and Davidson Projects:** The company holds 100% interest in the Taken property, Tam property, Tsacha property, and Tommy Lake property located in the British Columbia. It also holds a 100% interest in the Davidson property located in the British Columbia. In March 2009, the company announced an option with Richfield Ventures Corp. to explore and advance the Davidson property, whereby Richfield can earn up to a 75% interest in the Davidson property.

### Significant Events

On October 16, 2009, Silver Quest Resources Ltd. announced that it has entered into an option agreement with North Bay Resources of Skippack, PA to acquire a 75% interest in the Fawn and Buck Properties (4 claims totaling 406.78 hectares).

On October 16, 2009, North Bay Resources Inc. announced that it has agreed to terms on an earn-in joint venture with Silver Quest Resources Ltd. on North Bay's Fawn gold-silver property in central British Columbia, Canada. The Fawn property is situated on the Nechako Plateau of central British Columbia, approximately 120 kilometres southwest of Vanderhoof and 180 kilometres west of Quesnel. The property covers 1,005 acres, and includes the Buck claims 6 kilometres to the east.

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

### Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

### **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
