In addition, the company involves in the exploration and production of oil and gas properties; and coalfield development business, as well as in conducting alternative energy business. As of April 30, 2009, it participated in 34 oil and gas blocks in 17 countries, as well as in 4 LNG projects; and had proven oil equivalent reserves of 520

million barrels of oil equivalent. The company also had interests in 4 working coal mines and 5 exploration projects in Australia; and 1 coal project in China, as well as in a uranium exploration project in Canada. It sells its petroleum products directly to industrial and government users, as well as to retail and small industrial customers through the network of service stations and retail outlets; and operates an online B2B site for processing petrochemical product orders.
