The company focuses its activities on the Klipwal gold mine in South Africa (Klipwal Mine), a portfolio of mines and gold projects in Zimbabwe (Duration Gold Projects), and a coal project in South Africa known as the Kiepersol Colliery Project (Kiepersol Coal Project).

Klipwal Mine

The Klipwal Mine is located on state lands approximately 400 kilometres by road southeast of Johannesburg, Republic of South Africa and in the northern part of the province of KwaZulu-Natal. The Klipwal Mine covers approximately 7,927 hectares, and has an installed milling capacity of approximately 7,000 tpm.

Duration Gold Projects

The Duration Gold Projects are located on the Mvuma, Kwe Kwe, and Bulawayo greenstone belts and are within a 100-km radius of the town of Kwe Kwe or of the city of

Bulawayo, Zimbabwe. They include 100% interests in the Gaika, Athens, Umviga, Durban, Sunace and Queens mines; a 65% interest in the Hope Fountain group of mines/prospects; and a 49% interest in a joint venture with Casmyn (Pvt) Ltd on the oxide ore deposits of Peter Pan–Sandy–Tiberius mines.

Kiepersol Coal Project

The Kiepersol Coal Project is located in the province of Mpumalanga, South Africa approximately 35 kilometres southwest of Piet Retief and 95 kilometres from the Klipwal Mine. The company has an agreement to acquire, directly and indirectly, from Eastern Solid Fuels (Pty) Ltd. of South Africa a 51% interest in the Kiepersol Coal Project through the acquisition of 51% of the issued shares of Matt Trading (Pty) Limited.

Significant Events

On November 30, 2009, Duncan Park Holdings Corp. announced that it has entered into a letter of intent pursuant to which it may enter into an option and joint venture arrangement with Sphere Resources Inc. with respect to the Dome property located in Ontario's Red Lake gold district. Under the terms of the letter of intent, Duncan Park would join Sphere in exploring the Dome property being optioned by Sphere from Global Minerals Limited pursuant to which Sphere may acquire an undivided 75% interest in Global's right, title and interest in the property. The Dome property is comprised of 13 unpatented mining claims (34 units), which cover approximately 500 hectares and are located about 1 kilo meter east of the Town of Red Lake and 3 km southwest of Balmertown, Ontario.

History

Sphere Resources Inc. was founded in 1987. The company was formerly known as Mandorin Goldfields Inc. and changed its name to Sphere Resources Inc. in 2007.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
