## **About Surgutneftegaz**

Surgutneftegas engages in the exploration, development, drilling of oil properties in Russia. The company incorporates research and development, exploration, production, oil and gas processing and marketing divisions. It operates in 16 regions of the Russian Federation.

### **Oil production**

In 2007, Surgutneftegas produced oil at fields in Western Siberia, – core area of its operation, as well as to develop infrastructure of its new area, – Eastern Siberia. It is developing 49 fields in Western Siberia. It also constructed 141 horizontal wells and fulfilled 1,123 hydrofracturing operations, including 420 hydrofracs on old well count. In 2007, the field produced 223.5 thousand tons of oil.

### **Gas production**

In its gas production segment, the company facilitates development of infrastructure for gathering, treatment, transportation and utilization of natural and associated petroleum gas. In 2007, Surgutneftegas produced 14.1 bcm of associated petroleum gas (APG). It commenced production of natural gas at the Talakanskoye field. The company operates

9 compressor stations across transmission lines and 7 low stage compressor stations. It constructed approximately 129 kilo meters of gas pipeline. In 2007, the company's hydrocarbon output was totaled 64.5 mn tons of crude oil and 14.1 bcm of gas.

#### Power generation

In 2007, the company commissioned 2 gas turbine power plants (GTP) at the Zapadno-Chigorinskoye and Verkhne-Nadymskoye fields, and started construction of additional 2 GTP plants at the Talakanskoye and Rogozhnikovskoye fields. In 2007, Surgutneftegas operated 15 gas turbine power plants with total capacity of 379.5 mW, and 3 gas piston power plants generating 22.3 mW.

#### Oil refining and gas processing

Refining and petrochemical segment is represented by its refinery, – KINEF, Ltd., – which produces various petroleum products (17 types or 85 grades). It sold approximately .2 mn tons of refined products through its own marketing network.

#### Gas processing

Gas processing is a key stage in the company's system of production, gathering and utilization of associated petroleum gas. The company's gas processing plant, – Gas Processing Division (UPG), – converts associated petroleum gas into stripped petroleum gas and liquid hydrocarbons.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
