Telular Corporation engages in the design, development, and distribution of products and services that utilize wireless networks to provide data and voice connectivity among people and machines.

Products

The company creates solutions based on the development of specialized wireless terminals that work in conjunction with software systems to provide integrated event monitoring and reporting services for machine-to-machine (M2M) applications.

The company's Telguard solution supports residential and commercial security dealers. The Telguard solution includes a specialized terminal unit which interfaces with commercial security control panels and then communicates with its event processing servers to provide real-time transport of alarm signals from residential and commercial locations to an alarm company's central monitoring station.

The company's TankLink solution combines a specially designed cellular communicator, wireless data services, and a Web-based application into a single offering which allows end-users to remotely monitor the level of product contained in a given tank vessel. Its cellular communicator interfaces with various commercially available sensors and



conveys the level-reading of those sensors to its event processing servers. This information commonly feeds a vendor managed inventory (VMI) program. Its existing TankLink systems are installed in fuel and lubricant tanks. Additional market segments served include industrial chemicals, food additives, and waste water treatment.

The company's FCT business targets both commercial and residential consumers, who use FCTs for voice, fax, and Internet access over the wireless networks. An FCT allows users to simultaneously plug in a standard telephone, fax machine and a computer data line, which the FCT then makes functional over the wireless phone network.

The company's Telguard and TankLink M2M solutions operate in conjunction with realtime, transaction processing servers, which receive data, transform the data, and immediately forward the result to its customers. The M2M tank level monitoring and Telguard security solutions are a combination of hardware product design along with software system design.

Geographical Markets

The company's Telguard products and service are sold in the United States. The majority of M2M tank applications served by it are located within the United States and Mexico. It focuses its FCT sales efforts in North and South America and also has sales in Africa, Asia, and the Middle East.

The company's international sales team is based in Miami and covers key markets, such as Latin America. These markets include significant cellular carrier customers in countries, such as Mexico.

Customers

The company's Telguard product customers are security equipment distributors, who sell to independent security dealers and security service dealers, totaling approximately 2,700 customers. FCT customers are either cellular carrier or value added resellers (VARs) allocated to niche market applications enabled by its FCT products. Its major customers include ADT, a securities systems provider in the United States.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

How to overcome the weaknesses that can make the threats a reality?

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
