As of December 31, 2008, the company managed a total installed capacity of 671 megawatts (MW), comprising 360 MW on its own account and 311 MW for third parties. Its portfolio of wind projects under

development amounted to 2,580 MW. It operates wind farms in France, Germany, and Morocco, as well as developing wind projects in France, Italy, India, and Brazil. The company also operates in the non-wind sector, corresponding to other activities, such as environment, hydraulic, and biofuels.

Acquisitions

In January 2008, the company acquired 100% of Compagnie Eolienne de Detroit (CED), which has a beneficial interest in a wind farm installed in the Kingdom of Morocco. It includes 84 windmills for total installed capacity of 50.4 MW.

In 2008, the company also acquired SNCs Les eoliennes de Bel Air and Les eoliennes du Plateau; Centrale Eolienne of Chermisey; Beaudignecourt; Avalon Ltd; Belmonte Green Energy Srl; and Mendecino Green Energy S.r.l. It also purchased the interest held in the SNCs L'Ardèche and Le Charmois.

History
