The Thermo Master™ technology converts organic materials normally designated as wastes suitable only for disposal, into useful end products such as animal feed ingredients and fertilizers. The high temperatures eliminate pathogenic (disease causing) bacteria and other microbes as well as any other noxious inclusions such as insect eggs or larvae. The thermophilic (heat loving) organisms that carry out the process improve the overall nutrient profile of the end product, which is then dried to a stable pellet, easy to handle, transport and use. Thermo Tech™ has specific service agreements with Planet Earth Operating Services Inc. that support it in the normal conduct of business in North America and elsewhere.

## Products

The Company owns and licenses the Thermo Master™ technology. Thermo Tech™ launched its business in North America, where its flagship, 1200 ton per day capacity Hamilton Bio Conversion plant is located. Most recently, with the acquisition of Firmaplus Sdn Bhd of Malaysia, the Company has targeted and is opening a market within one industrial sector that can reasonably be projected to require 100 plants or more.

Using the patented process, wet organic waste materials are transformed to pelleted dry products, well suited to commercial feeding of livestock. These pellets can be conveniently shipped, handled and blended by feed companies and end users to make final diet formulations. The end result is valuable feed products and water.

## Firmaplus Market

Firmaplus holds the license for Malaysia, Indonesia, Thailand and the Philippines. Malaysia currently has about 380 palm oil mills, which operate year round, at an average of approximately 20 hours per day. Malaysia produces over 50% of the world's palm oil (some 11 million tonnes). Indonesia, located "right next door" is growing in capacity and importance and currently accounts for something in the range of 40% of the world production of palm oil. There are in excess of 200 plants in Indonesia with more in the planning.
