As of December 31, 2009, the company held interests in approximately 750,000 gross exploration acres. As of December 31, 2009, its proved reserves were 5.8 MBbls (million bbl), and its proved plus probable reserves were 9.1 MBbls.

#### Exploration Permits

The company holds 10 exploration permits: Rigny le Ferron, Chateau Thierry, Aufferville, Nemours, Courtenay, Joigny, Malesherbes, Mairy, Nogent sur Seine, and Leudon en Brie.

Rigny le Ferron: The company holds a 100% working interest in, and operates, the Rigny le Ferron permit, which covers approximately 82,780 acres.

Chateau Thierry: The company holds a 100% working interest in, and operate, the Chateau Thierry permit, which covers approximately 192,495 acres.

Aufferville: The company holds a 100% working interest in, and operates, the Aufferville permit, which covers approximately 33,112 acres.

Nemours: The company holds a 50% working interest in the Nemours permit, which covers approximately 47,197 acres (23,598 net acres for its working interest) and is operated by Lundin Petroleum AB.

Courtenay: The company holds a 100% working interest in, and operates, the Courtenay permit, which covers approximately 93,159 net acres located east of the Neocomian Complex.

Joigny: The company holds a 100% working interest in, and operates, the Joigny permit, which covers approximately 33,112 acres.

Malesherbes: The company holds a 100% working interest in, and operates, the Malesherbes permit, which covers approximately 65,977 acres.

Mairy: The company holds a 30% working interest in the Mairy permit, which covers approximately 109,715 acres (32,914 net acres for its working interest) and is operated by Lundin Petroleum AB.

Nogent sur Seine: The company holds a 100% working interest in, and operates, the Nogent sur Seine permit, which covers approximately 65,730 acres.

#### Exploitation Concessions

The company holds two exploitation concessions covering two producing oil fields in the Paris Basin: the Neocomian Complex and Charmottes fields (Dogger and Trias).

Neocomian Complex: The company holds a 100% working interest in, and operates, the two concessions (Chateaurenard and St. Firmin Des Bois) covering the Neocomian Complex, which consist of a group of four smaller field units. As of December 31, 2009, the complex had 80 producing oil wells. An exploration prospect has been identified in the Dogger objective located 500 meters below the Neocomian producing reservoirs. The Chateaurenard concession covers approximately 11,268 acres, and the St. Firmin Des Bois concession covers approximately 3,973 acres.

Charmottes: The company holds a 100% working interest in, and operates, the Charmottes concession, which consists of two oil fields at different horizons (Dogger and Trias). As of December 31, 2009, the fields had seven producing oil wells. The Charmottes concession covers approximately 9,019 acres.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
