The Tumbleweed menu offers both distinctively seasoned, spicier versions of popular Mexican dishes, as well as an assortment of grilled steaks, ribs, pork chops, chicken and seafood selections.

The key elements of the Tumbleweed concept include:

One Concept Offering American Southwest Grilled Items and Mexican Food: The Tumbleweed menu is intended to distinguish Tumbleweed from competing Mexican and casual dining concepts by offering both distinctively seasoned, spicier versions of burritos, enchiladas, tacos, salads, and other popular Mexican dishes, as well as an assortment of grilled steaks, ribs, pork chops, chicken and seafood selections.

The Tumbleweed menu features distinctively seasoned versions of popular Mexican dishes and mesquite grilled selections. Customers receive complementary chips and salsa, and chooses from a selection of appetizers including such Tumbleweed specialties as chile con queso and chili, as well as nachos, quesadillas, buffalo chicken strips, Southwest eggrolls and turkey wings. The Mexican menu offers burritos, enchiladas, tacos, chimichangas and other items served both individually and in various combination dinners accompanied by rice and refried or baked beans.

Customers may also choose from an assortment of fajitas, ribs, chicken, steak, pork chops, and seafood prepared over an open gas- fired mesquite wood grill and served with Texas Toast, salad, and a choice of baked potato, baked sweet potato, southwest fries, smashed taters, corn on the cob, grilled veggies, Santa Fe rice, and refried or baked beans. Mesquite grilled items are available as sandwiches as well as entrees. A variety of salads featuring refried beans, seasoned beef, shredded or fried strips of chicken, mesquite grilled chicken or seafood, and other traditional ingredients rounds out the menu. In an effort to increase the frequency of guest visits, the Company introduces new items, which complement present menu selections through seasonal menus. The Company also has a lunch menu, which is available during lunch hours as a complement to the complete menu.

Tumbleweed restaurants typically contain full-service bars offering a wide assortment of mixed drinks, wines, domestic and imported beers and featuring the Tumbleweed margarita and Texas Tea.

Restaurant Locations

The locations of Restaurants are Evansville, Ft. Wayne and Terre Haute in the state of Indiana; Bowling Green and Louisville in the state of Kentucky; Cincinnati, Columbus, Dayton and Cleveland in the state of Ohio.

Franchised Restaurants

As of December 29, 2002, the company has six franchisees that owned and operated 19 Tumbleweed restaurants. Floyd Knobs, New Albany, Salem and Jeffersonville in the state of Indiana; Shelbyville, Frankfort and Lexington in the state of Kentucky are franchised by TW-Indiana,LLc. Rockford, Illinois; Appleton, Franklin, Madison, Milwaukee, New Berlin and Park Place in the state of Wisconsin are franchised by Diamondback Management Corp. The other franchises are TW-Seymour, LLC (Seymour, Indiana);TW-Glasgow, Inc.(Glasgow, Kentucky); TW-Bullitt, Inc.(Hillview, Kentucky) and TW-Somerset, LLC (Somerset, Kentucky).

Licensed Restaurants

As of December 29, 2002, the company has six licensed restaurants located outside the United States in England, Turkey, Egypt, Germany and Jordan.
