In September, 2005, the company entered into a Sales and Customer Service Agreement with E-Source Equipment, Inc., a Texas corporation (E-Source), pursuant to which E-Source has agreed to sell, place and provide customer service for the company's 'Ice Island' self-contained ice production machines (the Ice Island Machines). The arrangement with E-Source would be exclusive as to convenience stores, supermarkets, liquor stores and the airline packaged ice markets to the extent.

Ultra Pure Water Technologies, Inc. was incorporated in 1989 in the state of Florida. It was formerly known as VDO.COM, Inc.; Ventech International Corp.; and CTC 3, Inc.
