Kalnica-Selec Uranium project -Slovakia

The company, by an agreement entered with the Slovak government in 2005, has been granted the right to carry out exploration activities in an area referred to as the Kalnica-Selec property located in western Slovakia. The company's subsidiary, Beckov Minerals, S.R.O. (Beckov) holds these claims. The Kalnica-Selec Uranium project is located in the Povazsky Inovec Mountains and comprises 28.91 square kilometers.

Buck Lake project claims - Ontario

The Buck Lake project is located approximately 27 kilometres west of the Lac des Iles Palladium Mine and 100 km north of Thunder Bay, Ontario along the western edge of the circular structure. The Buck Lake Project consists of 119 claim units. As of December 31, 2008, the company increased the size of its Buck Lake portfolio. The



additional property areas consist of 8 claims totaling 66 units staked surrounding the eastern portion of the main discovery area at the Buck Lake project.

Gwyn Lake Gold property –Ontario

The Gwyn Lake Gold property is located within the Beardmore – Geraldton Gold Belt, 15 km east of Beardmore, Ontario. The property is comprised of three claims totaling 20 claim units (320 hectares). The property measures approximately 2 km by 2 km. The Gwyn Lake gold property is host to greenstone belt-style gold mineralization located within banded iron formations.

Significant Events

On January 13, 2010, Ultra Uranium Corp. has entered into an option agreement with Pierre EnTerprises Ltd. for Pierre to acquire a 70% interest in the Beardmore Gold Property located in the Thunder Bay Mining Division, Northwestern Ontario, Canada. The Beardmore Gold Property comprises 3 claims (20 claim units) covering an area of approximately 2 square kilometers in Ultra's Gwyn Lake gold project located within the Beardmore-Geraldton Gold Camp. Ultra holds an additional 11 claims in the area.

History

Ultra Uranium Corp. was founded in 1981.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
