United Envirotech, Ltd., a holding company, provides environmental engineering services in People's Republic of China (PRC). The company principally operates through its two PRC subsidiaries include NOVO Envirotech (Tianjin) Co. Ltd. (NOVO Tianjin) and NOVO Envirotech (Guangzhou) Co. Ltd. (NOVO Guangzhou).

The company provides their services on environmental consultancy and engineering to approximately 50 subsidiaries and branches within the China Petrochemical Corporation (Sinopec) Group. The company provides both environmental engineering and environmental consultancy solutions to various customers in the chemical, petrochemical, pharmaceutical, wastewater treatment, food & beverage and textile & dyestuff industries.

Activities

The company's two principal activities include - Environmental Engineering that engages in the design and implementation of integrated systems for engineering solutions, based mainly on its membrane technology, to address the specific needs of its customers, and; Environmental Consultancy that assists its customers to proactively identify their environmental health and safety (EHS) problems and set up a framework

for EHS management.

In addition to the environmental engineering and consultancy businesses, the company has also acquired 2 wastewater treatment plants under the Transfer- Operate-Transfer scheme of arrangement during 2005. They are located at Liaoyang City, Liaoning province and Xintai City, Shandong province. These plants have a treatment capacity of approximately 200,000m³/ day and 80,000m³/day respectively. The company owns, manages, and operates these treatment plants.

The company has also developed and installed a number of Two Way Flow (TWF) membrane systems for the clarification of fermentation broth and to yield concentrations of antibiotics, vitamins and amino acids for clients like North China Kangxin Pharmaceutical Co. Ltd and Tianjin Pharmaceutical Co. Ltd. In addition, the company has designed a Microfiltration (MF) integrated system for the McDonald's chain of restaurants in the PRC, which was the only approved drinking water purification system used in many of its restaurants in the PRC.

Segments

The company's operates its business in three segments - Consultancy, Engineering, and Treatment.

Consultancy: The company's consultancy segment provides environmental consultancy solution in the area of environmental health and safety.

Engineering: The company's engineering segment engages in the design and implementation of integrated environmental engineering solution based on membrane technology.

Treatment: The company's treatment segment renders waste water treatment services.

Subsidiaries

The company's principal subsidiaries, through which it operates are NOVO Tianjin and NOVO Guangzhou. The company's other subsidiaries include - United Guo Zhen Water Treatment (Liaoyang) Co. Ltd (Liaoyang) that operates water treatment plant/PRC, in which it has 99% interest; and United Envirotech Water Treatment (Xintai) Co. Ltd (Xintai) that operates water treatment plant/PRC in which it has 100% interest.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
