United Paragon Mining Corporation engages in the exploration, development, exploitation, recovery and sale of gold.

The company, through an Operating Agreement executed in February 1987 and Option and Operating Agreement in November 1987 with Camarines Minerals, Inc. (CMI), has the rights to operate the mineral properties in the name of CMI that are covered by mining lease contracts, including the right to occupy the other real properties of CMI.

The principal properties subject of an operating agreement with CMI consists of 1,207 hectares with confirmed mineral resources and prospective exploration areas. The approved Mining Lease Contracts with the government cover 394 hectares. The mining claims covered by operating agreement with CMI are all located in the Paracale-Jose Panganiban District. The total area covered by mining lease is 394.8094 hectares consisting of 56 mining claims all located at Paracale, Camarines Norte.

### Drilling

Exploration drilling in the year 2004 was the continuation of the evaluation of the mineral



property in the San Mauricio area, Jose Panganiban, Camarines Norte. Only one diamond drill hole was completed on January 21, 2004 with a total of 504.80 meters. This exploratory hole was drilled to explore and probe the north extension of the Spokane vein below L300 under the ultramafic cover. The projected north extension passes thru the interpreted granodiorite dome on the Philippine Air Force reservation area. Two significant intercepts were noted. The first intercept averaging 0.46 Au, g/t was intersected from 281.80 to 282.20 meters depth of 40 cm diorite, slightly broken and showing green silicate minerals and specks of 1-2% Pyrite, Chalcopyrite, Sphalerite and minor galena. The second intercept of 0.22 Au, g/t assay was at 500.50 to 503.70 meters depth comprising of a 3.20 meters quartz diorite moderately silicified to fractured and showing green silicate minerals with pyrite and chalcopyrite, 1-3% sphalerite and galena.

#### Reserves

As of January 1, 2005, the indicated mineral resources inventory includes 3,160,737 MT at 10.89 Au g/t containing 1,106,393 ounces of gold.

# **ANALYSIS FEATURES**

### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### **Enhanced SWOT Analysis**

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



### Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
