The company operates through two divisions, Neurobionix and Biotronix.

Neurobionix Division

The company's Neurobionix division develops the Bionized CLS (closed-loop sensing) Neuromodulator, an implantable device that features neurosensing and neurostimulation capabilities.

The company's Neurobionix division develops implantable CLS devices, such as the Bionized CLS Neuromodulator, for the measurement (sensing) and stimulation of peripheral nerves for the restoration of physiological functions, involving neurosensor implants and neurostimulators. The Bionized CLS Neuromodulator was designed to



treat, among other conditions, gait disorders (foot drop), which would result from a lesion of the central nervous system caused by a stroke or multiple sclerosis. The Neurostep integrates the Bionized CLS Neuromodulator. The Bionized CLS Neuromodulator would be tailored to meet requirements for the development of new treatments for clinical applications, such as obesity, sleep apnea, and stroke.

Biotronix Division

The Biotronix division develops biomechatronic products to support or replace peripheral limbs in what is known as the orthotics and prosthetics (O&P) market.

The company's partner in this area, Ossur, launched the Power Knee product, which is a motor-powered and artificially intelligent prosthesis for above-knee amputees. The Power Knee restores lost muscle function and enables amputees to perform normal daily activities.

In April 2009, the company and Otto Bock HealthCare GmbH formed a joint venture to develop and commercialize products, which are developed by its Neurobionix division.

Significant Events

On December 17, 2009, Victhom Human Bionics Inc. announced that it had entered into a new license agreement to replace previous collaboration agreement with partner Ossur and sold certain Biotronix assets to Ossur.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
