The company has interests in 8 Prospecting Licenses and 3 Reconnaissance Licenses covering an aggregate area of 2,389.82 square kilometres. The licenses are located over the Bui Gold Belt, Sefwi Gold Belt and the Maluwe Basin in northwest Ghana. The company holds a 100% interest in the licenses. It retains a 4.9% interest in the Akrokerri Prospecting License in southern Ghana.

#### **Banda Ahenkro Joint Venture**

In 2007, Birim concluded a two-part agreement with Newmont and NUSA comprising: the Banda Ahenkro Joint Venture on the 488 square kilometre Banda Ahenkro Property on the Sefwi Belt; and the waiving of NUSA's back-in rights on Birim's Bui Belt properties.

## The Tinga Property

The Tinga Prospecting License covers 46.25 square kilometres in northwest Ghana, located approximately 450 kilometres northwest of the capital Accra. The company, through its subsidiary EBI (Ghana) Ltd., holds a 100% interest in the license.

## Kampti Project

The Kampti Project is located in Poni Province close to the border with the Ivory Coast. The Kampti Project is a single permit with an area of 244.5 square kilo meters that is wholly-owned by the company.

## Titao Gold Project

The Titao Gold Project is located in Yatenga Province in northern Burkina Faso. It consists of three contiguous permits that are wholly-owned by the company.

## Significant Events

On September 17, 2009, Volta Resources Inc. announced that its wholly-owned subsidiary, Birim Goldfields Mali SARL, has been granted the 125 kilo metres Massabougou exploration permit in southeastern Mali. The Massabougou permit is underlain by Birimian (PaleoProterozoic) lithologies located in the Bagoé geological subprovince, which extends southward from southern Mali into northern Cote d'Ivoire.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
