Warwick Valley Telephone Company provides communication services to the residential and business customers in the United States.

The company provides telephone service to customers in the contiguous towns of Warwick, Goshen and Walkill, New York, and the townships of West Milford and Vernon, New Jersey as the incumbent local exchange carrier (ILEC). It also provides voice over Internet protocol (VoIP), Internet, and video services.

The company also operates as a competitive local exchange carrier (CLEC) in areas that are adjacent to its ILEC territories and beyond.

Segments

The company operates through two segments, Telephone and Online.

Telephone Segment

The Telephone segment provides telecommunications services, including local network services, network access services, long distance services, directory services, and other services and sales.

Local network services: The company's local network services include traditional dial tone, which is primarily used to make or to receive voice, fax or analog modem calls from a residence or business. Included under local network services are custom calling services, such as caller ID, call waiting, voice mail, and other value-added services. These features allow users to display the number and/or name of callers, signal to the telephone user that additional calls are coming in, and send and receive voice messages.

Network access services: The company's network access services connect a customer's telephone or other equipment to the transmission facilities of other carriers that provide long distance and other communications services.

Long distance services: These services result from the transport of intraLATA telecommunications traffic (traffic within its Local Access and Transport Area) to a destination that is outside of a local calling area. The company also provides wire line interLATA long distance (traditional long distance service) to its customers.

Directory services: The company's directory service group publishes and sells yellow and white page advertising in print and online.

Wholesale services — The company has expanded its wholesale services with the acquisition of certain assets of US Datanet Corporation (US Datanet). These services provide origination and termination services to carriers, as well as mid-sized and large business customers.

Conference services — The company is also providing voice conferencing services with the acquisition of certain assets of US Datanet.

Other services and sales: These services relate to billing and collections provided to other carriers, inside wire, circuit, wireless services, and reciprocal compensation.

Within the telephone business unit, the company has a wholly-owned subsidiary — Warwick Valley Long Distance Company, Inc. (WVLD), which resells toll telephone services to its subscribers. In addition, broadband services are provided through the interconnection of its fiber optic network with other carriers.

Online Segment

The Online segment (Online) provides broadband and dial-up Internet access services, VoIP Services, and video over its landline network and in partnership with DIRECTV, Inc., a provider of digital television service (DIRECTV). Broadband Internet and dial-up Internet services allow a customer access to the Internet.

Services and Products

The company provides broadband Internet and dial-up Internet access services using its network and by reselling other suppliers access services. VoiceNet Complete is a hosted VoIP service primarily targeted at

small- and medium-sized business customers. The company's Video products enable it to bundle voice, video, and data, the Triple Play, to its customers. The company's Video product offers approximately 140 digital channels. It offers a Triple Play bundle that includes voice, Internet, and DIRECTV. Additional products offered by this segment include banner advertising, domain name registration, and Web hosting.

Orange County-Poughkeepsie Limited Partnership

The company owns an 8.108% limited partnership interest in the Orange County-Poughkeepsie Limited Partnership (O-P). Verizon Wireless of the East, L.P. (Verizon) is the partner and the majority owner and has a 91.892% interest. O-P provides wholesale cellular telephone service throughout the Orange County-Poughkeepsie Metropolitan Service Area.

Customers

The company's major customer includes The Universal Service Fund (USF).

History

Warwick Valley Telephone Company was founded in 1902.
