Western Forest Products, Inc., an integrated softwood forest products company, operates in the solid wood and pulp businesses in British Columbia. The company's primary business is solid wood and includes timber harvesting, reforestation, forest management, sawmilling logs into lumber and wood chips and value-added lumber remanufacturing. The company's pulp operations consist of producing and marketing Northern Bleached Softwood Kraft (NBSK) pulp. All of its operations are located in the coastal region of British Columbia. The company's products are sold in approximately 30 countries worldwide.

The company's annual timber harvest from regulated forest tenures includes approximately 3.9 million cubic metres in the year 2004. It had an additional 100,000 and 19,000 cubic meters respectively of volume available from unregulated timber licences and private lands. The company also has a supply of 330,000 to 350,000 cubic metres of sawlogs under a sawlog purchase agreement with a third party.

The company's harvest operations are conducted on government owned timberlands, in accordance with the terms and conditions of three tree farm licences (TFLs), seven forest licences (FLs), timber licences (TLs) and private lands external to these tenures.



The company's manufacturing plants consist of: six sawmills with a total annual production capacity of approximately 1.1 billion board feet of lumber and 700,000 units of wood chips; one pulp mill with a total annual production capacity of approximately 275,000 air dried metric tones (ADMT) of pulp; a value-added lumber remanufacturing plant with an annual drying and production capacity of approximately 80 million board feet; and a log merchandiser.

The company's most of the lumber products are sold green (not kiln-dried or air-dried) and certain specialty products require kilndrying. It offers a line of traditional components for the Japanese market. The company's focus in Europe is kilndried, high-grade specialty products used predominantly in Germany, Italy and the United Kingdom.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
