The company has 5 surface coal mines in Montana, North Dakota and Texas and 2 coal-fired power generating units with a total capacity of 230 megawatts in North Carolina.

#### **Properties**

The company had an estimated 425.1 million tons of proven and probable coal reserves as of December 31, 2009. The company is a party to 2 leases with the Crow Tribe covering 18,406 acres of land at its Absaloka Mine.

The company's four power plants include Limestone Generating Station, Colstrip Units 3&4, Colstrip Units 1&2, and Sherburne County Station. It provides transportation for its mine-mouth customers and sells coal plus lignite on a Free On Board, or FOB, basis to its other customers.



Rosebud: The Rosebud Mine has two contracts with the adjacent Colstrip Station power generating facility. The company has an agreement at Units 3&4, which covers approximately 7.0 million tons per year.

Absaloka: The Absaloka Mine operates primarily in the open market and has approximately contracts with various parties that totaled approximately 6.0 million tons in 2009.

Savage: The Savage Mine supplies approximately 0.3 million tons per year to the local Lewis & Clark Station under an agreement.

Beulah: The Beulah Mine supplies approximately 2.5 million tons per year to the adjacent Coyote Station under an agreement. It also supplies approximately 0.5 million tons per year to the rail-served Heskett Station under an agreement that expires during 2011.

Customers: The company's customers include Xcel Energy, Western Fuels Assoc., Midwest Energy, and Rocky Mountain Power.

**Power Segment** 

The company owns two coal-fired power-generating units in Weldon, North Carolina with a total capacity of 230 megawatts, which it refers to collectively as ROVA.

Customer: ROVA supplies power to Dominion Virginia Power under long-term contracts.

Westmoreland Coal Company was founded in 1854.

# **ANALYSIS FEATURES**

### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
