#### **Properties**

As of March 31, 2009, the company had interests in the Lowland, Luc Bourdon, and Garden Island properties.

#### Lowland

In 2008, the company entered into an option agreement with Metalex Ventures Ltd. (Meta- lex) and Arctic Star Diamond Corp. (Arctic) pursuant to which it was granted the option to acquire a 50% interest in certain claims of Metalex's and Arctic's James Bay properties located on and around the 'Ring of Fire' and covering approximately 36 square kilometers.

#### Luc Bourdon Property



The company has entered into an option agreement with Golden Valley Mines Ltd. (Golden Valley) and Noront Resources Limited (Noront) providing it and Noront the option to acquire from Golden Valley an aggregate 70% interest in the Golden Valley property located in the lowland region of James Bay, Ontario.

#### Garden Island

The company has entered into an agreement with TSR Resources Inc. where TSR granted it an option to acquire an individual 20% right, title and interest for a resulting aggregate of 10% right, title and interest in and to 296 mineral claims located in Piedmont, Courville, Pascalis, and Senneville Townships of Quebec, which mineral claims are collectively known as the Garden Island property.

## Significant Events

White Pine Resources Inc., Noront Resources Ltd. and Golden Valley Mines Ltd. has a joint venture project along the 'Ring of Fire' in the James Bay Lowlands. In 2009, White Pine initiated a drill program to test six regional VTEM anomalies on the joint venture claim group. Four of the six anomalies produced significant to anomalous Zn-Cu intersections and values. The ZTEM survey has identified low resistivity anomalies directly over the zone that suggests that it could also continue potentially to greater depth at the G1 and G3 anomalies.

On December 14, 2009, White Pine Resources Inc. announced that it has signed a letter of agreement for the acquisition of an option to acquire the MZ Gold Property located in the Boston Creek gold mining district south of Kirkland Lake, Ontario.

## History

The company was incorporated in 1979. It was formerly known as WSR Gold Inc. and changed its name to White Pine Resources Inc. in 2008.

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



## Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
