Products

Wall – clay blocks: Clay Blocks are used for load-bearing exterior and interior walls, as well as for non-load-bearing partition walls or fillwork. The company clay blocks for walls are sold under the POROTHERM brand.

Roof: The company offers clay roof tiles to cover pitched roofs, under the KORAMIC brand. It offers a line of special tiles and ceramic accessories for each type of tile, including ridge tiles and verge tiles. It also offers non-ceramic accessories for roofs with KoraTech. The KoraTech line includes products, such as sturmFIX, a new fixation system developed by KORAMIC, and KoraFlex, an aluminum connection and flashing roll.

Through its 50% holding in Bramac, the company also produces concrete roof tiles that are used to cover pitched roofs, primarily in Austria and the southeast region of Europe.



The main areas of application for these products are found in new residential construction. It also serves the concrete roof tile market in Great Britain with the acquisition of Sandtoft Ltd.

Facade - facing bricks: Facing bricks are used in visible brick architecture: facades and interior walls are made from or covered with these bricks. Its facing bricks are sold under the TERCA brand. Corium is a ceramic facade system that can be used in both new construction and renovation. ArGeTon is the company's brand for rear-ventilated ceramic facade boards, which permit the ideal combination of traditional clay building materials with contemporary building products, such as glass, aluminum or steel.

Pavers: Pavers by the company are produced as clinkers made of clay or as concrete pavers and slabs. These materials are used by homeowners (for driveways, paths, terraces and garden design), as well as in public areas (sidewalks, open areas and pedestrian zones). Its payers are offered under TERCA and SEMMELROCK brands.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
