Xyratex Ltd. provides enterprise-class data storage solutions and storage process technology. The company designs, develops, and manufactures enabling technology that provides its customers with data storage products to support storage and data communication networks.

Segments

The company operates in two business segments, Networked Storage Solutions (NSS) and Storage Infrastructure (SI).

NSS Products

The company designs, develops, and manufactures data storage solutions. Its storage subsystems comprise modules, such as its storage controllers and disk drive enclosures, and support a range of high-speed communication technologies and cost and performance specifications. Its hard disk drive (HDD) and solid state drive (SSD) based storage subsystems support a range of high-speed communication technologies. The company's products are generally targeted at the mid-range and enterprise markets.



The company's focus areas include strategic alliances and partnerships with organizations such as the Storage Bridge Bay (SBB) working group, the SCSI Trade Association (STA), the Storage Network Industry Association (SNIA), the Green Grid, and the International Disk Drive Equipment and Materials Association (IDEMA). The company operates partnerships with key suppliers both of technology and manufacturing services.

The company's products provide the high speed digital interfaces to multiple disk drives using Fibre Channel (FC), SAS, and SATA technologies. These interfaces are provided with redundancy and improved diagnostic capabilities ensuring system availability even during maintenance. The products that the company provides to OEMs are typically referred to as JBOD (Just a Bunch of Disks) subsystems. It further refines the JBOD designation as SBOD (Switched Bunch of Disks) and EBOD (Expandable Bunch of Disks) subsystems.

The company's OneStor family of products complies with the SBB Version 2 specification and incorporates dynamic cooling, power, and modularity, allowing it and its OEM customers to create a range of storage solutions with re-use of design and components. It provides failsafe/redundant power, interconnects, cooling, and serviceability. In 2009, the company completed production release of three OneStor configurations, including its first Small Form Factor (SFF) enclosure. Its products, including OneStor and its legacy 3U and 4U platforms, support 12, 14, 16, 24, and 48 disk drive configurations.

The company's application storage systems integrate extended ATX (EATX) or Storage Bridge Bay (SBB) motherboards inside a storage enclosure integrated with the necessary device drivers, BIOS, and server and enclosure management software modules to fulfill many different storage application requirements. Various network connections can be integrated into the storage enclosures to address the requirements of the healthcare, video, IP storage, data deduplication, and cloud storage markets.

The company's storage subsystems are internally managed by a range of firmware modules and features. These firmware modules can monitor the internal performance of the subsystem, create internal environments, communicate independently with remote service, support organizations, and integrate with its customers' controlling software and management technology through interfaces.

The company also provides RAID technology to protect users from failure of disk drives. Its RAID technology provides solutions with a range of features, including RAID 6 (the



ability to deliver data even with two concurrent disk drive faults). Its products include its F6500 SBB-based RAID controller which supports its OneStor family of products. These products are SAN 'solutions' particularly suited to sell to vertical-focused OEMs who do not have their own RAID data protected controllers.

SI Products

The company's SI product portfolio includes process, inspection, and test equipment utilized in disk drive head fabrication, disk drive substrate, and media manufacturing and disk drive final assembly and test. The company provides HDD production test equipment, media write equipment, media cleaning systems, and media automation.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
