The company involves in cultivating, processing, marketing, and distributing various food and agro-byproducts. It also operates a small concrete plant in Baiyin City, Gansu Province, China.

Products

The company's food and agro-byproducts are processed from premium specialty agriculture products grown in northwest China in six agricultural product categories: fresh fruits, vegetables, field crops, specialty crops, seeds, and eggs. Its primary product offering includes approximately 30 agriculture products under 6 product categories with the products, including field crops, such as cotton, corns, barley, wheat, flax, and alfalfa; vegetables, such as onions, potatoes, beet, and peas; fruit, such as apples, pears, and apricots; specialty crops, such as hops, wolfberries, cumin, and liquorices; seeds, such as black melon seeds, sunflower seeds, corn seeds, and flax

seeds; and poultry, such as eggs. It also produces various additional fresh fruits and vegetables which supply the local and provincial markets.

Customers and Markets

The company sells its products through a nationwide sales and distribution network covering 16 provinces, including Gansu, Shanxi, Beijing, Shandong, Liaoning, Guangdong, Tianjin, Shanghai, Ningxia, Qinghai, Hebei, Inner Mongolia, Xinjiang, Jilin, Hubei, and Guizhou; and approximately 100 cities in China. As of December 31, 2009, this network comprised approximately 100 major and 80 minor distributors.

The company's products also sold directly to food processors, as well as processed within its company and then resold to supermarkets or other distributors, or further processed into retail food products. The company also sells its fresh products within Gansu province, as well as nationally to food processors and distributors, or directly to the supermarkets.

The company's customers are based primarily in China and include national and international companies. Its products are also sold as feed for livestock, ingredients for Chinese traditional medicines, as well as other ingredients in the food industry.

The company's competitors include COFCO and China Grains and Oils Group (CGOG).

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
