About Zijin Mining Group Co. Ltd.

Zijin Mining Group Co., Ltd. operates as a mining conglomerate in China. It primarily engages in the exploration, mining, processing, refining of gold and non-ferrous metals and other mineral resources, and the sale of mineral products. The company invests and controls 14 subsidiaries and produces approximately 10 tones of gold a year. As of December 31, 2004, the company had the proven reserves of approximately 315 tones gold metal, approximately 3,450,000 tones of copper metal, approximately 600,000 tones of zinc metal and approximately 187,890,000 tones of iron metal. As of the same date, the company also obtained the 59 exploration rights for approximately 1,612.79 sq. km.

The Company possesses Zijinshan Gold Mine (which is the single open pit gold mine in the PRC); Guizhou Shuiyindong Gold Mine; Jilin Hunchun Gold-Copper Mine; and Anhui Guichi Paodaoling Gold Mine, all of them are in operation, as well as Xinjiang Ashele Copper Mine, Fujian Zijinshan Copper Mine, Anhui Tongling Jiaochong Gold Mine and Sichuan Jiuchaigou Caodi Gold Mine, all of them are under construction, together with other exploration projects.

In 2004, the company produced 10,663 Kgs of gold. Guizhou Shuiyindong Gold Mine produced 1457 kg of gold in 2004 and reported 56.62 tones of gold reserve at 1.95 g/t

grade.

Hunchun Zijin's 4000t/d ore-processing plant was built and in operation in August 2004. The total ore process capacity of the mine reached 5000t/c. In 2004, the mine produced copper concentrates consists of 618 kg gold and 2,264 tones of copper.

Ashele copper mine produced 4,798 tones of copper concentrates with copper reaching 823 tones. Paodaoling Gold Mine's production facilities primary ore were in operation, and it coordinated the production of oxide gold ore and primary gold ore. Xinjiang Mengku Iron Mine produced 26,000 tones of iron concentrated in the year 2004.

Fujian Zijina Investment Co., Ltd. invests and obtains actual progress in copper manufacturing plant, electricity plant, ore processing chemical plants, standard factory construction and mine explorations.

As of December 31, 2004, Zijinshan Gold mine had 162 tones of gold reserve at 0.3 g/t grade or above, and 173 tones at 0.2 g/t grade or above; Sichuan Jiuzhaigou Caodi Gold Mine had 36.576 tones of gold reserve; and Guizhou Huajiangbeixie Coal Mine covers an area of 34 sq. km, had a reserve of approximately 60 million tones.

In April 2005, the company entered into an agreement with Western Mining Co, Geology Team No. 6, Changdu Co and Mining Development Co. four independent parties to set up a mining joint venture in northwest China. The joint venture would be mainly engaged in the development of the Tibet Yulong copper mine, which has 6.5 million tons of approved reserves of copper.

Significant Events

In December 2008, Zijin Mining Group Co., Ltd. has entered into a contract to form a joint venture with Minxi Xinghang State-Owned Assets Investments Co. Ltd. to build a copper refinery in Shanghang, Fujian.

History

Zijin Mining Group Co., Ltd. was incorporated in 2000. The company was formerly known as Fujian Zijin Mining Industry Co., Ltd. and changed its name to Zijin Mining Group Co., Ltd. in 2004.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
