technological advancements like blockchain and AI to enhance platform efficiency and reduce operational costs. On the other hand, the Asia Pacific region is anticipated to witness the fastest growth during the forecast period. This growth is attributed to the rising number of SMEs, rapid digitalization of economies like China and India, and increasing smartphone adoption that facilitates access to alternative lending platforms.
