Geographically, North America dominates the BFSI security market owing to a mature financial sector and heightened awareness of cybersecurity threats. Europe follows closely, driven by stringent regulatory frameworks such as GDPR that mandate robust

security protocols. Meanwhile, the Asia Pacific region is anticipated to experience the fastest growth, underpinned by rapid digitalization, the proliferation of fintech, and rising investments in cybersecurity infrastructure by major economies such as China and India.
