Abstracts

Global E-Prescribing Market is valued approximately at USD 1.2 billion in 2020 and is anticipated to grow with a healthy growth rate of more than 23.3% over the forecast period 2021-2027. E-prescribing is a software programme that allows patients or end users to electronically transmit prescriptions to pharmacies of their choice. The fundamental aim of e-prescribing models in an EHR or HIT system is to ensure that complete, accurate, and clear prescription orders are transmitted and received efficiently, allowing pharmacy processing and fulfilment to run smoothly, avoiding workflow disruptions and delays in patient care. The need to reduce increasing healthcare costs and growing government support for the use of EHR solutions are two significant factors driving demand for such solutions. Furthermore, the global COVID-19 outbreak has resulted in a higher patient volume in hospitals, requiring better patient data management. This is likely to boost demand for these solutions further. For instance, the SUPPORT for Patients and Communities Act, approved by the United States Congress in 2018, mandates the use of e-prescriptions for all controlled drugs by January 2021 under Medicare Part D. furthermore, Due to the advantages of telehealth consultations, such as improved patient involvement in remote monitoring and reduced overhead costs, players in the EHR market started integrating the telehealth feature with their existing solutions. During the COVID-19 crisis, however, the use of this function surged. However, rise in concerns regarding security and workflow may impede market growth over the forecast period of 2021-2027.

Geographically, North America is expected to dominate the overall market. The United States has the largest market share in the North America region, owing to government

efforts and incentive programmes to promote the E-prescribing system, as well as growing demand for E-prescribing systems in the US. However, The Asia Pacific area is adopting digitalization with the goal of simplifying their whole operation and ensuring patient safety. The key nations in this region that are actively implementing e-prescribing systems include Japan, Australia, Taiwan, South Korea, India, and China. Furthermore, government incentives for the use of EMR systems, the huge number of COVID-19 patients, the ageing population, and the increased frequency of chronic illnesses are all factors to consider.
