States, banks issued approximately 680,000 reports of check fraud, almost twice the number reported in 2021. Moreover, rising adoption of cloud-based financial risk management software and rising investment in adoption of digital infrastructure in banking system are creating new opportunities to the market growth. However, complexity associated with software installation and configuration and high costs of deploying financial risk management software are restraining the market growth throughout the forecast period of 2023-2030.
