Global Fintech-as-a-Service Platform Market is valued at approximately USD XX billion in 2020 and is anticipated to grow with a healthy growth rate of more than 10 % over the forecast period 2021-2027. Fintech-as-a-Service Platform is a software that helps business owners, companies, and consumers to manage and monitor their financial operations, by utilizing algorithms and other software.
