#### **Abstracts**

Global Healthcare Interoperability Solutions Market is valued approximately USD 2.3 billion in 2019 and is anticipated to grow with a healthy growth rate of more than 12.7% over the forecast period 2020-2026. Since last few years, healthcare system is undergoing a massive revolution as technology is extensively used to engage patients, caregivers, and consumers to offer real-time information and support care delivery with improved use of data and analytics. Through these needs, the use for healthcare interoperability solutions witnessing a strong upturn. Healthcare interoperability solutions are mainly utilized to overcome the complication of healthcare domain. However, shortage of trained healthcare IT professionals, and increase in complexity with the lack of consistent data are the few factors expected to hamper the growth of the market over the forecast period of 2020-2026.

North America is the leading/significant region across the world in terms of market share owing to the rise in demand for quality healthcare delivery, along with surging need to curb increasing healthcare expenditure in the region. Whereas, Asia-Pacific is anticipated to exhibit highest growth rate / CAGR over the forecast period 2020-2026, due to the growing medical tourism, and increasing government expenditure on healthcare facilities in the countries like China and India.
