Abstracts

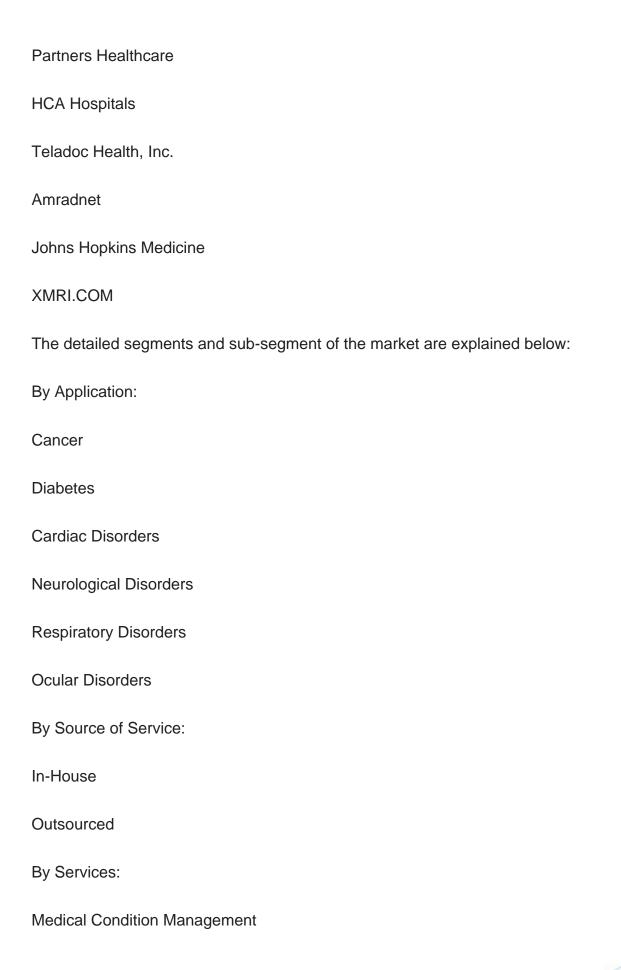
