### **Abstracts**

Global Mid-Revenue Cycle Management and Clinical Documentation Improvement Market was valued at approximately USD 3.42 billion in 2023 and is expected to grow with a healthy CAGR of 7.2% over the forecast period 2024-2032. Moreover, the rising complexity in healthcare billing and increasing healthcare expenditure across the globe are driving the need for comprehensive mid-revenue cycle management solutions that can handle unstructured data and reduce errors.

Furthermore, the integration of AI and automation in healthcare revenue cycle management is expected to significantly enhance operational efficiency, reduce manual errors, and improve decision-making processes. This technological shift is opening up new opportunities for market players, particularly in developing economies where healthcare systems are rapidly evolving.
