Abstracts

Global Over-the-Counter Derivatives Market is valued at approximately USD XX billion in 2021 and is anticipated to grow with a healthy growth rate of more than XX% over the forecast period 2022-2029. Over the Counter (OTC) Derivatives are financial contracts that do not trade on the stock exchange rather they are traded in the OTC marketplace via a broker-dealer network. These OTC derivatives can be options, forwards, futures or other agreements and their value is based on that of an underlying asset such as stock, commodity, bonds and so on. Derivative trading offers protection against the risks associated with the price movements of the underlying assets. The traders dealing with derivatives securities are known as hedgers. There are different types of OTC derivatives are there including interest rate derivatives, commodity, and equity derivatives, forex, credit, and fixed-income derivatives among others. The increasing expansion of the foreign exchange market and growing digitization in the financial sector as well as strategic initiatives from leading market players are key factors accelerating the market growth.

The increasing expansion of the foreign exchange market is contributing to the growth of the Global Over-the-Counter Derivatives Market. For instance, according to a survey conducted by the Bank of England, the UK in October 2022 – in April 2019, the average daily turnover in the UK foreign exchange market was valued at USD 3576 billion, and the market further increased to USD 3755 billion in April 2022. In addition, during April



2022, the average daily turnover of OTC interest rate derivatives was valued at USD 2626 billion. Also, increasing the use of trading platforms for investments and the rise in participation of security exchanges would create a lucrative growth prospectus for the market over the forecast period. However, the lack of transparency & legal risk in OTC derivatives stifles market growth throughout the forecast period of 2022-2029.

The key regions considered for the Global Over-the-Counter Derivatives Market study includes Asia Pacific, North America, Europe, Latin America, and Rest of the World. North America dominated the market in terms of revenue, owing to the presence of leading market players and the increasing expansion of the foreign exchange market in the region. Whereas Asia Pacific is expected to grow with the highest CAGR during the forecast period, owing to factors such as rising trade in over-the-counter trading in commodities and stocks coupled with the growing emergence of digital trading platforms in the region.
