## **Abstracts**

Global Patient Registry Software Market is valued at approximately USD 1.39 Billion in 2021 and is anticipated to grow with a healthy growth rate of more than 15.2% over the forecast period 2022-2028.

A patient registry is a database that helps in gathering clinical as well as non-clinical patient data for assessment of specified results for a population in terms of a particular condition, disease, or exposure, and which also aids in predetermined data for clinical,

scientific, or policy purposes. The growing penetration of the EHRs and other eHealth solutions, the rising need for adopting patient registry data for post-marketing surveillance, and the increasing number of initiatives for building patient registries are the primary factors that may stimulate the market demand across the globe. For instance, in May 2018, the South Korean Government invested around USD 33.4 million to strengthen their artificial intelligence (AI) system for proficiently analyzing a patient's medical registry in order to provide enhanced treatment and diagnostics options. Thereby, rising government investments for the adoption of patient registry software are further accelerating the market growth. However, an unavailability of trained and skilled professionals and growing concerns regarding data security and privacy impede the growth of the market over the forecast period of 2022-2028. Also, the emergence of cloud-based patient registry solutions is anticipated to act as a catalyzing factor for the market demand during the forecast period.

The key regions considered for the Global Patient Registry Software Market study include Asia Pacific, North America, Europe, Latin America, and the Rest of the World. North America is the leading region across the world in terms of market share owing to the growing incidences of diseases, the emergence of novel technologies, and increasing target population. Whereas, Asia-Pacific is anticipated to exhibit the highest CAGR over the forecast period 2022-2028. Factors such as the growing geriatric population, favorable government policies, and increasing pressure to curb medical errors would create lucrative growth prospects for the Patient Registry Software market across the region.
