## **Abstracts**

Global Skin Health Foods Market/Dermatology Functional Foods Market is valued at approximately USD 1929.5 million in 2021 and is anticipated to grow with a healthy growth rate of more than 6.6% over the forecast period 2022-2028. Functional food is food that presents more health benefits than its nutritional value. Dermatology functional foods have an additional function by adding new ingredients that are consumed for anti-ageing, anti-allergy, and treating several skin conditions. The growing consumption of nutrient-enriched foods, rising health awareness among consumers, coupled with the increasing number of product launches and developments by the key market players are soaring the global market demand.
