Abstracts

Global Soil Amendments Market is valued approximately at USD XX billion in 2021 and is anticipated to grow with a healthy growth rate of more than XX % over the forecast period 2022-2029. Soil Amendments are the organic or inorganic materials applied to agricultural lands that improves the characteristics of the soil. They can be used for different types of soils such as loam, slit, clay and sand etc. The Soil Amendments market is expanding because on the back of rising demand for organic food products and growing awareness about soil health management.

According to the Forschungsinstitut f?r biologischen Landbau FiBL in 2020, around 1.6% of the farmland globally are organic. Liechtenstein (Europe) had the highest organic share of total farmland (41.6%), followed by Austria (26.5%) and Estonia (26.5%). (22.4 percent). Organic agriculture accounts for 10% or more of all agricultural land in 18 countries. By the end of 2020, nearly 75 million hectares had been organically managed, representing a 4.1 percent or 3 million hectares increase over 2019. Incorporation of soil amendments into fertilizer formulations devices and growth activities in developing countries create lucrative opportunities for the market. However, short shelf of soil amendments hampers the market growth throughout the forecast period of 2022-2029.

The key regions considered for the Global Soil Amendments Market study include Asia Pacific, North America, Europe, Latin America, and the Rest of the World. North America dominates the market with highest revenue, owing to the presence of coal



mining, rock mining, smelting & refining sites.
