Abstracts

This issue is about new registrations of pesticide formulations in China in 2022. According to ICAMA, China recorded 879 registrations of pesticide technical in 2022, of which 77 were new registrations and 802 were renewal ones.

There were five kinds of newly registered pesticide technical in 2022, with herbicide ones accounting for over

40% OF THE TOTAL NEW REGISTRATIONS. AMONG THREE LEVELS OF TOXICITY OF THE NEWLY REGISTERED PESTICIDE TC/TKS,

the low-toxic ones took up a share of 81%. All new registrations had been applied by 52 Chinese registrants

located in seven regions in China. In addition, 42 kinds of active ingredients were involved in the 77 new

registrations of pesticide technical, with 8 registered for the first time.

Since 2020, MARA has issued a number of policies and stipulated that approvals would be given to pesticide

registrations for export only. In 2022, 29 new export-only TC&TK products were approved in China, including
