In June, VK3 price climbs up on a MoM basis. Hubei Zhenhua Chemical Co., Ltd. and Brother Enterprises Holding Co., Ltd., two large-scale producers of VK3 in China, have stopped quoting or raised their prices owing to price hike and tight supply of VK3's key raw material, chrome ore. As a result, VK3 market attracts much attention and the product witnesses a small rise in price in June.

The Dietary Supplement Dosage Form and Technical Requirements for Filing (2021 Version) has come into force starting from 1 June, 2021, and gelatinized confection is listed for the first time. It diversifies domestic dietary supplement dosage forms for filing, and nutrient gummies will have a 'legal' identity as a 'gelatinized confection' in the dietary supplement field, which will inject new impetus into domestic nutrient gummy market growth.

Initial public offerings of Shanghai Haoyuan Chemexpress Co., Ltd. and Shandong Link Science and Technology Co., Ltd. have drawn much attention from market. The former proposes to be listed on the Shanghai Stock Exchange, with eldecalcitol being one of its planned products in the fund-raising project; while the latter is to float on the Shenzhen Stock Exchange and its silica for non-rubber industry can be used in vitamin production.

Recently, RedBull trademark disputes have intensified in Chinese market. Insiders believed that it is difficult to access the final result of the 'RedBull' Brand battles. Red Bull Vitamin Drink Co., Ltd., China's leading company in functional beverage market, not only faces the possibility of losing product sales channels, but also facing competition from many rivals. Its subsequent development will have impact on the domestic functional drink market.
