In February 2023, Globalia Group and International Airlines Group (IAG) reached an agreement for the sale of the entire airline company Air Europa. This closes a long process which began with the pre-agreement adopted in November 2019, later modified in January 2021, and terminated to seek an alternative in December 2021. During early 2022, IAG extended a loan of EUR100 million to Air Europa, with an option of converting it into up to 20% of the latter's equity.
